# Plumbers for sewer hookups

Womble identified two area plumbers to be approved for sewer hookups. Tommy Wright (Wright's Plumbing) and Austin Dyer (Drain Right, from Benton) will be on call for new sewer hookups, attaching the plumbing from the city's sewer lines to homes. Both are experienced with the Rockport system. Residents will be required to use one of these two, with more to be added to the list as they are identified and approved. This will prevent further instances of connection problems due to plumbers inexperienced with our system.

# Bank account changes

Womble: the council has not taken action at this point because they just received the audit. They will review the audit this week.

Audit review should be on the September meeting agenda.
