## Citizen appearance

Jim Dyer spoke to the council about a neighbor's dogs attacking other dogs and cattle. The dogs have been dragging trash into his yard. The same neighbor's horse has been getting out through an open gate and chasing his (Dyer's) dogs; one of his dogs ran off for a week after being chased. Last week six dogs attacked his two Blue Heelers; one suffered serious injuries. They tried to attack the female again Saturday.

Dyer said he has called the owner and wants her to pay the veterinarian's bill for treating the injured dog. He has security camera footage, with sound, of the attack. He requested an incident report from the Rockport Police Department as documentation to file with small claims court.

Morales said the police department would provide the report. He also verified to a question from Dyer that a property owner has the legal right to protect his property from vicious animals.
